With regard to the estimated value of the contract, the complexity of the contract subject, the necessity of financial independence and the concessionaire's creditworthiness is necessary for the tenderer to prove his ability to meet the financial liabilities without difficulty.

Justification for the adequacy to point 2.2:

The requirement to provide an overview of the achieved turnover results from the concept the contract subject is executed, when the tenderer must have the necessary volume of financial resources throughout the whole period of the contract subject execution. The Public Procurement Authority needs to verify the economic situation of the tenderer and its financial stability, especially with regard to the fact that the tenderer will be responsible for the operation and maintenance of assets under the administration of the Public Procurement Authority has set this condition in accordance with law.

The tenderer to prove the financial and economic status may use the financial resources of another person pursuant to § 33 par. 2 of the Public Procurement Act.

The Public Procurement Authority, in accordance with § 33 par. 3 of the Act requires that the tenderer and the person whose resources are to be used for demonstration of financial and economic status in accordance with § 33 par. 2 shall be responsible for the execution of the concession agreement communally. For this purpose, the tenderer shall submit a joint responsibility agreement signed by the tenderer and by the person through whom the tenderer proves compliance with the financial and economic status terms for participation. The explicit, precise and specific commitment in joint responsibility on concession agreement pursuance shall accrue from the wording of the joint responsibility agreement.

In the case when the tenderer fails to provide for objective reasons the document specified by the Public Procurement Authority to prove economic and financial status, the tenderer shall proceed according to § 33 par. 4 of the Public Procurement Act.

The tenderer shall submit a declaration on word of honour signed by a person authorized to act on behalf of the tenderer, stating the turnover achieved for activities in the area covered by the contract subject for the previous three business years, or the years for which they are available depending on the origin or commencement of the operation. The minimum turnover in the area of the contract subject must be (cumulatively) amounting to 1 000 000 EUR.

For the purpose of this public procurement, the turnover in the area covered by the contract subject shall be considered as a turnover for ITU transloading, ITU handling, and ITU storage.

III.1.3) Technical and professional capacity

Justification for the adequacy to point 3.2:

With regard to the fact that, during the concession period, the successful tenderer will have in use the property belonging to the contracting authority's administration of assets, the contracting authority is required to ensure that the tenderers are entities able to guarantee the ability to execute the subject of the contract in accordance with the relevant quality management standards.

The tenderer shall submit at least 1 operation reference (the operation shall include at least management, administration and maintenance) of at least one facility of "road - rail" or "water - rail" combined transport within previous three years from the date of the announcement of the public procurement, while the number of ITU transloaded over the last three years must be a cumulative minimum of 12 000 transloads in the operating facility in question. The contracting authority requires the reference in question to contain:

- identification data of the facility being operated,
- customer identification data (if applicable),
- the date of commencement of service provision in the facility concerned,
- the date of termination of service in the facility concerned,
- contact details of the manager of the facility (name and surname of contact person, phone number, e-mail),
- performance data of the facility, i.e. the number of transloads made in the facility in question over the last three years.

In the case where the facility concerned is operated under a contract with a third party (public contracting authority, contracting entity or other entity), the reference shall be acknowledged by its signature by the relevant contracting party. In the cases of privately operated terminals (i.e. without a third-party contract), the tenderer shall acknowledge the reference by its signature, or the person providing the capacity (as the case may be) and the tenderer for the reference shall also include additional evidence of operating of the facility in question, such as photographic documentation, a detailed description of the facility, operating rules, and so on.

To point 3.2:

Tenderers will be able to meet the terms of participation by submitting a valid Quality Management System Certificate issued by an independent institution confirming compliance with the quality standards according to the requirements of EN ISO 9001 for the area of subject of the contract. The contracting authority shall recognize, in accordance with § 35 of the Act, as equivalent certificates issued by the competent authorities of the member states, as well as shall accept other evidence submitted by the tenderer which is equivalent to the measures for ensuring quality according to the requirements for issuing the relevant certificate.

- at least at the level of the chief of shift/head of shift (supplying the terminal manager in operational matters in time of his absence, shall have experience of direct management of terminal operation and management of operational staff (dispatchers, crane operator, customs agents, service workers, etc.)).

The tenderer shall prove compliance of the term of participation pursuant to the point 3.3 by documents from which, minimally, the professional experience of a key expert must appear as an evidence, which the tenderer shall prove by the submission of professional CVs or by equivalent documents.

From each of the professional CVs of the relevant key expert or of the equivalent document must accrue the following information/facts:

- the name and surname of the relevant key expert,
- the employment history/professional experience of the relevant expert in relation to the subject of the contract (employer/customer, duration of employment/duration of professional experience / year and month from to, position which the relevant key expert held)
- the practical experience of the relevant key expert (identification of the combined transport terminal which is managed by the key expert, customer/employer, job description, position held in the combined transport terminal, period of year and month from to, name and surname of at least one contact person and phone number and email contact of customer/employer where the contracting authority will be able to verify the information).

- 5. The contracting authority shall provide the interested parties with comprehensive data and documents on the TIP Žilina project on a DVD disk, based upon a written request of the interested party delivered to the contact point of the contracting authority. The term of personal receipt of DVD disk shall be agreed in writing or by telephone with the contact person mentioned in point I.1). The receipt of the DVD disk in question will take place on working days from 8:00 a.m. until 4:30 p.m.
- 6. A successful tenderer shall be required to provide the contracting authority with all due diligence necessary to conclude the contract, so that it may be concluded within 25 working days from the day when the tenderer was called upon in writing to conclude it.
- 7. The duration of the concession period will be 30 years (360 months). The concession period begins on the first day of the month following the month in which the Day of start of operation occurred. The duration of the concession period will be 30 years.
