#### Loss of infrastructure capacity causes decline

A wave of infrastructure works-related railway line closures and extreme weather such as the torrential rains and flooding in Central Europe, Northern Italy, Switzerland and, recently, in Spain resulted in the loss of significant capacities for intermodal rail freight during the last months. This resulted, after a rebound during the April-June quarter, in a 0,79% decline of Combined Transport performance during the third quarter of the year. Reflecting on the high number of uncertainties and anticipated disruptions, the UIRR CT

Sentiment Index remains unchanged at "neutral" for the next 12 months.

Despite the successful diesel shuttle circumvention of the Rhine Valley line closure using the network on the French side of the Rhine, the 3-week-long disruption from 9 to 30 August resulted in the loss of many train paths, while substantial additional costs were incurred due to the longer transit times. Numerous other disturbances and disruptions continue to hinder the competitiveness of intermodal rail freight, which include the most important connection between France and Italy: the Fréjus line.

Europe's unpreparedness for climate change-related weather extremities was on display both during the summer heatwave and the floodings caused by torrential rain in September. The excessive damage caused to property and to the transport infrastructure resulted in numerous train cancellations. A standing European-level crisis and contingency mechanism would need to be established to help minimise the disruptions caused to cross-border traffic, especially since the frequency of such events is likely to increase in the future.

The summer months delivered progress in the European legislative theatre since the Hungarian Presidency of the Council produced a promising compromise proposal for the revision of the Combined Transport Directive. Discussions continue in the Council working group to find a solution that is acceptable to a majority of the Member States. The European Parliament named its rapporteur and shadow rapporteurs for the dossier, who will begin deliberation in the fourth quarter.

Following in the footsteps of Romania, new state aid programmes were announced in France, Poland and Spain to accelerate the development of intermodal rail freight, Combined Transport and transhipment terminals. UIRR applauds these initiatives but continues to argue in favour of a harmonised and transparently communicated European-level system of promotional programmes to achieve maximum effectiveness. The updated EU State Aid Guidelines and the Transport Block Exemption Regulation, as well as the revision of the Combined Transport Directive, should make up the required European regulatory framework.

The Combined Transport community continued with its development and investment initiatives, manifested in the launching of several new services, the opening of new or improved terminals, as well as kicking off terminal extension or construction projects. Confidence remains high that, through serving as the backbone of European freight-logistics, Combined Transport can meaningfully contribute to boosting Europe's competitiveness and to delivering the objectives of the Clean Industrial Deal.


